Hospitality/Dog Wagon

Over the years, our attendees have graciously donated their homemade cookies, candies, etc. to pass out at course breaks. We will also have coffee, soft drinks and water on the dog wagon. Please advise Mary Ann Gustafson if you will be able to help on the dog wagon.

Grounds/Facilities

We will return to the Blue Mountain Special Use Area near Booneville, Arkansas where we have successfully run our event for the past 20+ years. For those not familiar with the area, the grounds are divided into three 1-hour courses with a strong native quail population and are some of the finest field trial grounds in our nation where Gun Dogs and All Age Dogs alike can show off their abilities. The clubhouse with full kitchen facilities is the gathering point for hospitality, fellowship and food prepared for breakfast, lunch, and dinner by our cook last year - Kim Seaton. Depending on entries, we plan to have Kim do breakfast and lunch on Sun. Oct. 27 and then we will do our welcome BBQ on Sunday evening. Please let us know if you will be attending the BBQ when you send in your entries. Kim will then have breakfast, lunch and dinner through the week and end with lunch on Friday, Nov. 1st.

IMPORTANT NOTES:

Horse Stalls/Paddocks

There are box and stand-up stalls in the barn as well as outdoor horse paddocks/pens. Indoor box stalls and stand-up stalls in the barn are for one horse per stall. Outdoor paddocks/pens are for a minimum of two horses per paddock/pen. Anne Eichenberger will reserve stalls and outdoor paddocks/pens for Judges and key committee personnel only. All other horse stalls and paddocks/pens will be on a first come/first serve basis for your own use. You may NOT reserve or hold stalls and/or paddocks/pens for those arriving later than you. Due to limited availability of stalls and pens, you may not reserve/hold an outdoor pen during the day and move to the barn in the evening or vice versa. A concrete wash area for horses is located at the end of the indoor horse stalls adjacent to the first row of dog kennels.

Dog Kennels: Chain link dog kennels with plastic barrels are available for our use. There will be kennels available for bitches in season. Owners will be responsible for bitches in season at their campsites. Bitches in season need to be kept in their trailers and not walked around the other dogs. Hoses are located near the kennels for fresh water and cleanup. Please keep and leave your horse stalls/pens and dog kennels clean.

Please keep your dog kennels and horse pens clean. Last year Tony was not available to clean stalls. We will try to find someone local that would be willing to clean horse stalls at a reasonable rate. If not, please do your part to keep the areas clean. If the pens are not clean upon our departure, the club is charged a cleaning fee.

RV Pads: RV pads with electrical hookups are available as well as shower facilities and a meeting room in the clubhouse. Due to limited availability of RV asphalt pads, they are for those staying in their rigs on the grounds. Anne Eichenberger will coordinate the pads reserved for Judges and key committee personnel. All other RV asphalt pads will be on a first come/first served basis for your own personal use. There will be no reserving in advance for others arriving later than you. Across the road from the clubhouse is an additional camping area with shower and laundry facilities. Fees are as follows:

Animal Requirements:

A valid Negative Coggins is required on all horses. Please do not unload your horses on the grounds until Anne Eichenberger has checked your Coggins certificate. This is a State of Arkansas requirement for our club and there will be no exceptions to this requirement.

Proof of current rabies vaccinations should be available on all dogs brought onto the grounds. Bitches in season are allowed to compete in all stakes. If your bitch comes in season after the drawing, please advise the Field Trial Secretary as soon as possible so that bracing changes can be done and posted in the clubhouse. Please load bitches in season in the designated/flagged dog boxes at the back of the dog wagon only.

Training/Roading

No training will be allowed on the Championship grounds 30 days prior to the running of the National Championship. No roading of dogs on Championship grounds in gallery or prior to/or following day's running. You may use area across the road from clubhouse for roading.

Auction

Once again, no raffle this year but we hope to receive donated items to conduct an auction. Anyone having items to donate for the fund-raising auction should bring them to the event or get in touch with Mary Ann Gustafson. The auction is planned for Friday evening.

BACKGROUND

The ISCA National Field Futurity is formulated to encourage the breeding of high-quality field and hunting Irish Setters and recognize the breeders and owners for their efforts. Litter nomination birth dates are from November 1 - October 31 for the Futurity to be held at least two but not more than three years after the month of birth.

The Futurity is a 30-minute stake that is run on wild birds, if possible. A second series may be held at the discretion of the judges. The standard for the stake will be those of the American Kennel Club Derby Stake, with dogs judged primarily on inherited traits rather than training.

The most important of these are:

POINTING STYLE – Dogs must point staunchly and with intensity. Anything lower than a rigid, level tail shall be unacceptable.

SPEED – Dogs should be fast and move effortlessly; they should cover a lot of ground, be independent, and have an attractive style of running.

BIRD SENSE – Dogs must show an intense desire for birds and intelligence in the use of the wind in searching likely cover. A good nose is essential. To place, a dog MUST FIND AND POINT BIRDS. A blank gun will be used in this stake.

STAMINA – A dog shall show its stamina by the energy and strength it displays at the end of the brace.

HANDLING – Dogs should be biddable.

All futurity entries must have acceptable pigmentation and eye color according to the latest Standard published by the ISCA. If an owner/breeder is in doubt as to whether a dog will qualify, a color photograph should be sent to the Futurity Chairman at least six (6) months prior to the drawing. If this is not done, the Futurity Committee has the option to approve or disapprove the dog at the running of the Trial.

1996 Amendment: All Futurity entries must come to the trial in a full coat as Futurity dogs may have no more white than the standard allows for coat, color, pigmentation. Dogs may be clipped prior to running. 2003 Amendment: All Futurity entries are required to have an AKC DNA profile and be identified with a microchip implant. Dogs will not be drawn unless this information is received by the trial secretary prior to the start of the drawing.

NOMINATION PROCEDURE

There are two methods to nominate dogs for the Futurity:

- 1. Breeders may nominate all of the pups in the litter within 12 months of whelping by submitting a nomination form and a fee of \$50.00 per litter.
- 2. Owners may nominate individual dogs within 24 months of whelping by submitting a nomination form and a fee of \$50.00 per dog

Both breeders and owners need to be ISCA members or pending ISCA members to nominate litters or individual dogs.

All fees must be paid in US dollars.
